

CONSENT TO USE OF IMAGE

I, the undersigned hereby grant permission to (“Organiser”) to process, use and disseminate my image given by myself or captured by Organiser or the persons acting on their behalf, during the event or in connection with its promotion and organisation.

INFORMATION CLAUSE

1. *On the basis of this consent, Organiser processes your image as well as your name and surname.*
2. *The personal data administrator is, contact details: phone number, e-mail address.....*
3. *Personal data will be processed for the marketing of Organiser's activity.*
4. *The granting of the consent to data processing is voluntary and the refusal to provide the data prevents the achievement of the objective mentioned in the preceding point.*
5. *Personal data will be processed for as long as it is relevant for the purpose of advertising and presenting the event and Organiser's activity or until the consent is withdrawn.*
6. *You have the right to request access to the content of your personal data, to delete it and to restrict its processing. In addition, you have the right to withdraw this consent at any time without prejudice to the lawfulness of processing, the right to transfer data and the right to object to the processing of personal data.*
7. *You have the right to lodge a complaint with the President of the Data Protection Office.*
8. *Sharing your personal data with facebook.com and Instagram may result in image processing by technical methods for facial biometry. The aforementioned websites may process your data in an automated manner and can also be used for data profiling.*
